



STC PRESS RELEASE

The Petroleum Pricing Committee (PPC) met on Friday 4 December 2020 and after verification of the computation of the retail prices of Mogas and Gas Oil, as provided for under Regulations 8 of the Consumer Protection (Control of Price of Petroleum Products) Regulations 2011 (as amended), approved that the retail prices be maintained at their present level as per Regulations 5(1)(b) & 5(1)(a) as shown below:

Gas Oil	35.00

The Committee took note of the evolution of world prices of Mogas and Gas Oil and the status of the Price Stabilisation Account.

Mogas (L'essence): Based on the Reference Price of US\$400.25/metric ton for Mogas and an exchange rate of Rs40.40/US\$, the retail price of Mogas should have increased by 52 cents per litre or by 1.18%. However, as provided under Regulations 5(1)(b) the retail price of Mogas has been maintained at its current level i.e at MUR 44.00/litre, as the increase is less than 4%.

Gas Oil (Diesel): Using the Reference Price of US\$48.30/barrel and an exchange rate of Rs40.40/US\$, the retail price of Gas Oil has remained unchanged according to Paragraph 5(1)(a) of the Regulations since the percentage decrease is 0.14%, i.e. below 4%.

Based on the new Reference Prices, the retail prices of Mogas and Gas Oil remain unchanged at Rs44.00/Litre and Rs35.00/Litre respectively as shown below:
