



PRESS RELEASE

The Petroleum Pricing Committee (PPC) met on Friday 10 January 2020 and after verification of the computation of the retail prices of Mogas and Gas Oil, as provided for under Regulation 8 of the Consumer Protection (Control of Price of Petroleum Products) Regulations 2011 (as amended), approved that the retail prices be maintained at their present level as shown below as per Regulation 5(1) (c):

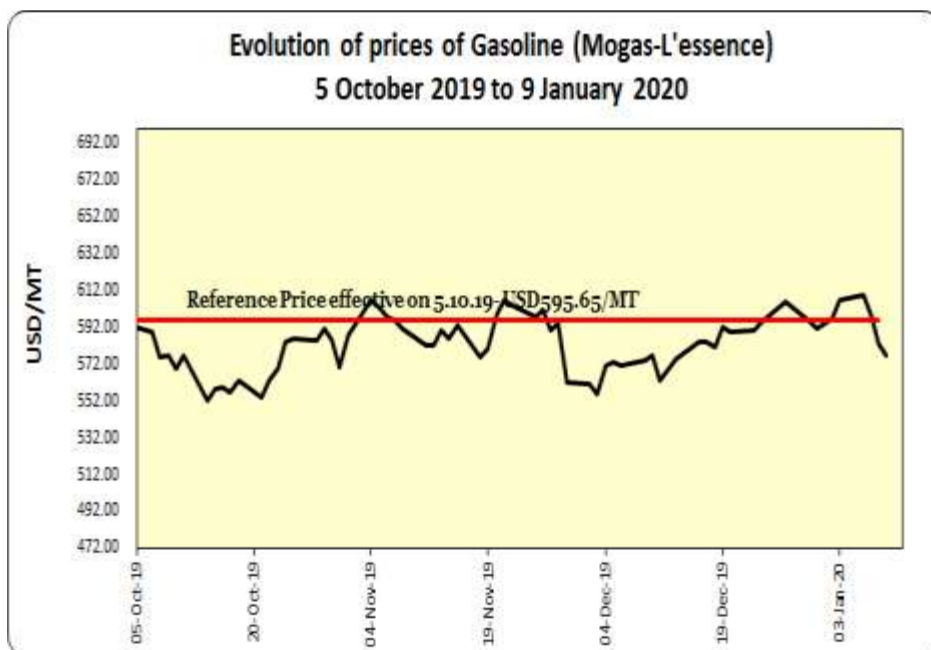
The Committee took note of the evolution of world prices of Mogas and Gas Oil and the status of the Price Stabilisation Account (PSA) which has a positive balance of Rs245.3 million on 10 January 2020.

Mogas (L'essence): Based on the Reference Price of US\$596.26 per M.Ton for Mogas, that is, the actual prices for October to December 2019 and the future prices for January to March 2020 and an exchange rate of Rs37.00/US\$, the retail price of Mogas should have been increased by Rs2.65 per litre or by 6.02%. However, as provided under Regulation 5(1) (c), the retail price of Mogas has been maintained by using fund from the PSA.

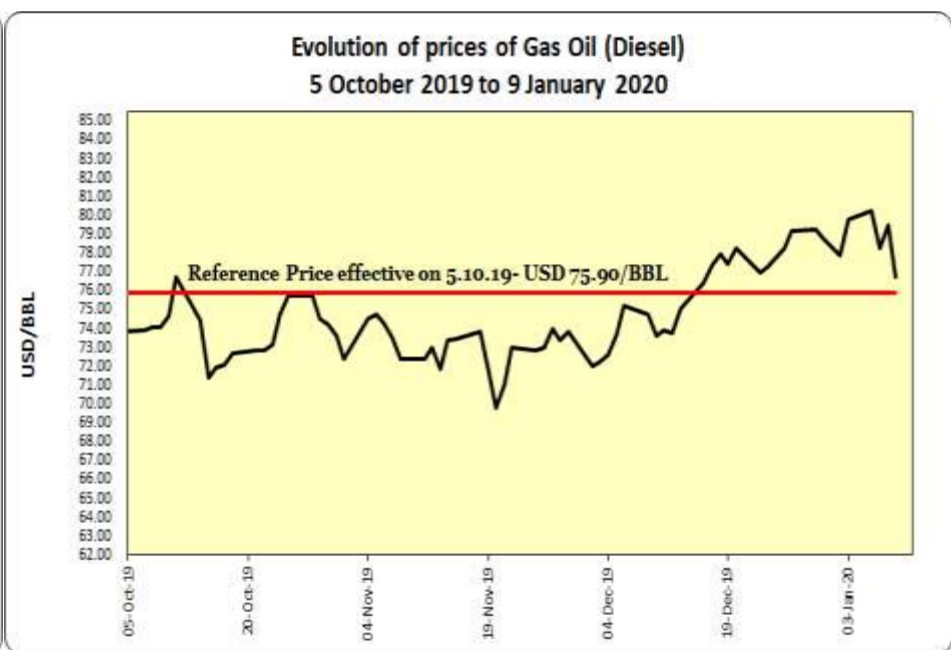
Gas Oil (Diesel): The Reference Price of US\$78.32 per barrel, that is the actual prices for October to December 2019 and the future prices for January to March 2020 and an exchange rate of Rs37.00/US\$ shows an increase in the retail price by Rs1.75 per litre or by 5%. However, as provided under Regulation 5(1) (c), the retail price of Gas Oil has been maintained by using fund from the PSA.

The evolution of the world prices of Mogas and Gas Oil since 5 October 2019 is shown in the graphs below.

Based on the new Reference Prices, the retail prices of Mogas and Gas Oil are maintained at Rs44.00 per litre and Rs35.00 per litre respectively as shown below:
